Together we are a community in service to the most vulnerable people of India, working on an individual-to-individual, heart-to-heart basis, letting them know that they have not been forgotten. The poor work hard and struggle to break a cycle of poverty that can span for generations. By building partnerships, engaging local leaders, and leveraging available resources, we develop integrated solutions to the underlying problems of poverty. Whether it's teaching new job skills, training teachers or improving access to health care, India Vision 2020 Sansthan works with communities to create sustainable solutions that go beyond addressing symptoms of distress.

History: Where all other organizations start with big resolutions, declarations, press conferences, prime offices, costly furniture's etc we started with a prayer to achieve the dream of a society based on equality and justice. This holy effort started on June 25, 2004 with just 15 volunteers. India Vision 2020 Sansthan is working with poor and marginalized people of Rajasthan India to end poverty and injustice. Organizational Structure

A suitable organizational structure for INDIA VISION 2020 Sansthan was a considerable challenge on its foundation day & after deep analysis of scope of work, it has adopted MATRIX form of organisational structure, with decentralized divisions.

INDIA VISION 2020 Sansthan has a Secretary who is responsible for overall administration, accounts and supervision of various programme groups and reports to the chairperson of the Executive Committee. There are many Project Teams and each team is coordinated by a senior and experienced professional volunteers who will be responsible for overall programme coordination and administration within the group. The Programme Manager would have one Programme Officer and one Programme Assistant as part of the core group team.

Financial management system

As we receive various grants to carry out our mission its our moral responsibility to be accountable for the same. For the better utilization of finances we carefully spent & the accounts are audited by Mr. M.L. Ranga, Director of M.L. Ranga & Co.

We also have an external audit and internal control mechanism to manage the project funds. We use the modern budgeting system like “performance budgeting” and “zero base budgeting” (instead of traditional outdated line item budgeting). In this budget system the fund is allocated for a targeted performance so that at the end of the day quantitative and qualitative data can show the output in required formats. Thus we have a very sound financial management for proper utilization of each and every penny of funding amount.

Target Group

Visualizing our vision of a DEVELOPED INDIA not only in terms of GDP & development of Metro cities, we strive to make an equitable and just society; we decided to forward our interventions to marginalized and disadvantaged section of the society who have been deprived of their rights and basic amenities of life. Thus, we identified woman, children, depressed classes, poor farmers and landless labours as our target groups. Rational of selecting woman as target group, is prevalence of dominant patriarchy in this region, which is responsible for the abysmal status of woman in the region. They play a subservient role in social fabrics and are relegated from any decision making process.

Form of intervention

INDIA VISION 2020 realizes its mission through two-pronged strategy. The organization endeavors towards promoting and nurturing leadership in civil society institutions and extending the livelihood base of the community as well as building their accessibility to the basic support services likes education, health, drinking water etc. INDIA VISION 2020 mobilized the community especially to the youngsters (who will be the citizen of DEVELOPED BHARAT), to participate in the process of local governance and assert their presence to obtain the available benefits for them.

Relationship with community

We do not envisage community at the recipient end and organization at the donor end. We strongly believe in the partnership approach where community will be responsible to implement the interventions designed with a view for sustainable development of their own and future generation.

Operational philosophy

In its operation India Vision 2020 Sansthan commits itself to the operational philosophy of collaboration and participation thus aim to usher in an era of constructive useful and complementary relationship between government and other voluntary agencies to address the problems of the poor and underprivileged in Rajasthan. It also aims to promote the principle of transparency, efficiency and accountability and strives to promote them in every individual.

ACTIVITIES PERFORMED IN THE YEAR 2017-18

1. Free Eye Check-up Camp for Villagers

Today, on 22-12-2017, a free eye checkup camp was organized by India vision 2020 sansthan at community hall in Fatehgarh Village. In this camp, the help of Aloka Vision was organized in this camp; free eye checks were checked for the people of Fatehgarh village. In this camp almost 380 people of FAtehgarh village were checked for free and eye was checked by modern machines. Aged people availed the camp and requested India Vision to organize this type of camp from time to time so that the villagers are given medical facilities could get

2. Economic Empowerment of Rural Artisans

We at this platform provide an opportunity to poor Handicraft Artisans to interact and trade with international buyers directly without any broker.

Our vision is to bring hope to those underprivileged artists and artisans who are back bone of Indian Handicraft industry but still deprived of socio-economic justice and exploited by the market forces. These artisans are voiceless and not having any common platform to raise their voice for legal & constitutional rights. They develop product by putting lots of hard work and so called exporter purchase this in pennies and sell the same in international market on a very high price.

We have launched a website with multi user facility to put their products on Internet so that they can interact directly with foreign buyers and get online orders.



INDIA VISION 2020 CONSORTIUM

This mission started twelve years ago, since that we realized that the people were suffering from mismanagement & uneven distribution of resources in a group of powerful hands. The lower middle class & BPL lack adequate information regarding political, social & economic rights & a weak will power (or criminal injustice mentality) of government officials & political leaders in enforcing the law of the land has worsen the situation. As a result better governance effective administration & a welfare state are still the distinct goals to be achieved by 1 billion people.

We have been working for making system clean by creating awareness among the people regarding Adult franchise & right to information as mostly who live in village are not aware of power of these two rights and they do not ask for any injustice being done with them by government officials.

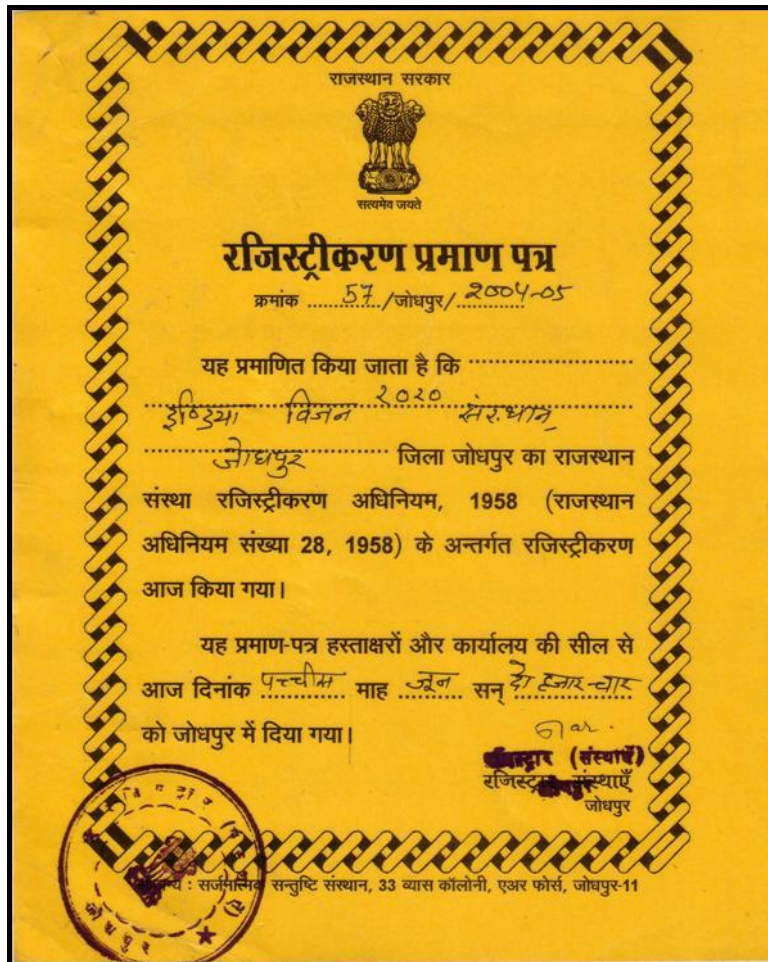



The Bank Account mentioned in your application should be used for receiving foreign contribution and no other amount should be credited to this account. 
